

**ORDER APPROVING AND AUTHORIZING THE MAYOR TO ENTER INTO
AN AGREEMENT WITH FIXING FATHERS, ONE DAY AT A TIME, INC.**

PRESENTED BY: Legislative Council

WHEREAS, the Town Of Hamden received funds from the United States Department of the Treasury (the "Treasury") pursuant to the Coronavirus State and Local Fiscal Recovery Fund under CFDA 21.027 ("ARPA Funds"), under Section 602 and 603 of Title VI the Social Security Act, as amended by Section 9901 of the American Rescue Plan Act of 2021 ("ARPA") (Subtitle M of Title IX of Public Law 117-2) and has allocated ARPA Funds to provide funding for appropriate and qualifying expenditures as allowed under the Treasury Guidance Interim Final Rule "Coronavirus State and Local Fiscal Recovery Funds" (86 Fed. Reg. 267878); and


WHEREAS, on or about October 21, 2024, the Legislative Council allocated \$20,000 in funding for the project known as Youth Mentorship Program; and

WHEREAS on or about October 21, 2024, the Legislative Council voted to identify Fixing Fathers One Day At A Time, Inc. as a vendor for the Youth Mentorship Program and the Town seeks approval of the Agreement and authorization for the Mayor to sign the Agreement.


NOW, THEREFORE, BE IT ORDERED that the Legislative Council of the Town of Hamden approves the Agreement between the Town of Hamden and Fixing Fathers One Day At A Time, Inc. and authorizes the Mayor to sign the agreement and any other documents necessary for such purpose.
