## 1. Call to order/Roll call -

Chairman Donald Moses called the meeting to order at 5:35pm. Commissioners in attendance: Director Erik Johnson, Commissioner Tony Delgrego, Commissioner Kenneth Good, Commissioner Howard K Hill, Commissioner Dashone Hughey, Commissioner Dan Smolnik

## 2. Review and approve minutes of November

Commissioner Donald Moses called a motion to review and approve the minutes from the previous November 13<sup>th</sup>, meeting; Commissioner Kenneth Good moved the motion and Tony Delgrego seconded the motion

## 3. Guest Speaker: Nancy Dudchik, President - Hamden Regional Chamber

President Dudchik spoke about the background of the Chamber's governmental affairs committee. President Dudchik and Chairman Moses have been in contact with each other, along with Commissioner Kenneth Good as the liaison, to ensure that an open-door policy is maintained between the Chamber and the Commission to support Hamden's business community.

The Chamber's Governmental Affairs committee have put together a survey for businesses within the Hamden area in order to receive feedback on what type of support these businesses require to recover from the pandemic. The following questions were asked:

- "Was your business adversely affected by the pandemic?" 70% said "Yes"
- "Are you still experiencing losses due to the pandemic?" 54% said "Yes"
- "Did you change your business model during the pandemic?" 80% said "Yes"
- "Was your business forced to close during the pandemic?" 69% said "No"

- "Did you have to lay off employees during the pandemic?" 70% said "No"
- "Were the problems your business experienced due to the supply chain?" 54% said "No"
- "Since the pandemic has eased, do you have a difficult time finding people to fill your positions?" 70% said "Yes"
- "Do you feel there needs to be assistance regarding Hamden small businesses regarding ARPA (American Rescue Plan Act of 2021) funds for small businesses?" 95% said "Yes"
- "Do you feel there needs to be assistance for Hamden non-profit organizations?" 95% said yes

## Each business was asked to rank the following 7 items in the order of most to least important:

- 1. A community campus, kitchen, warming center & library \$15.4 million (*Ranked #5*)
- 2. Early childhood development programs \$1 million (*Ranked #1*)
- 3. Grants and tax relief programs for businesses affected by the pandemic \$1 million (Ranked #2)
- 4. Grants for non-profits \$1 million (*Ranked #3*)
- 5. Mentoring programs (Ranked #4)
- 6. Extending sewer lines (*Ranked #6*)
- 7. Modernizing WhitneyVille Library (*Ranked #7*)

\*\*Director Erik Johnson inquired as to the number of businesses that responded to the survey and would like to make sure it is noted that President Dudchik reported close to 60 people have taken the survey so far

## 4. Chairman Report:

- **o Business community update** Chairman Donald Moses mentions that awareness on topics such as taxes and employment with large businesses are important to understanding the impact on the economic advances of the town of Hamden. Awareness of how these businesses operate as well as keeping an open line of communication with these businesses is critical.
- **o Hamden economic alliance** Chairman Moses has had several conversations with Director Erik Johnson and Mayor Lauren Garrett regarding developing alliances with lenders, universities and local businesses in order to create a plan that enhances the economic vitality of Hamden.
- **o Hamden Economic Revitalization** Chairman Moses emphasized the need for economic impact analysis in order to evaluate Hamden's economic opportunities. Chairman Moses has opened a line of communication with local universities to assess and identify how EDC can determine the present economic state of the business community and what is required to enhance it.
- **5. Executive Director Report:** Director Johnson and team have been working together to reassemble the town's community block grant program. \$2 million in funds have been identified in unspent funds that need to be reallocated. Approval and sign off from the human services committee has been received. The final vote on the revised budget with the Legislative Council will occur on December 20<sup>th</sup>, 2022.
  - There is a small business assistance program in which \$385,000 have been identified
  - In the works of developing a program in which CDBG dollars matched with ARPA dollars
  - \$120,000 in public service grants
  - Infrastructure improvements
  - Performing a study to ensure better access points for technology in parts of the community

- Affordable housing projects are in the works

High Meadows - New implementation schedule will involve public outreach and engagement. The High Meadows Facebook page or website will be updated regularly with any change
