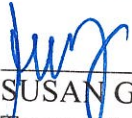
WHEREAS, the Town desires to establish a Newhall Foundations account to pay expenses related to impacted homes.

NOW THEREFORE, BE IT ORDERED BY THE LEGISLATIVE COUNCIL OF THE TOWN OF HAMDEN that (1) the Mayor and the Director of Finance are authorized to establish a Newhall Foundations account in the General Fund; and (2) there shall be an Appropriation of \$1,700,000 from the General Fund to the Newhall Foundations account to be used to pay expenses related to impacted homes.

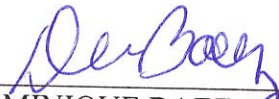
