### Availability of Plans for Public Comment and Review

The Town of Hamden has completed a draft of its Fiscal Year 2022 (PY48) Annual Action Plan. Hamden receives CDBG funds on an annual entitlement basis through the U.S. Department of Housing and Urban Development (HUD) for local projects that primarily benefit low-income persons. The Town's CDBG allocation for the 2022 Fiscal Year, which covers the July 1, 2022 through June 30, 2023, is \$479,238. The Town of Hamden will hold a public hearing and provide a public comment period for the proposed plans in accordance with federal regulations at 24 CFR 91.

The Town of Hamden has completed a draft substantial amendment of its Fiscal Year 2021 (PY47) Annual Action Plan. Hamden receives CDBG funds on an annual entitlement basis through the U.S. Department of Housing and Urban Development (HUD) for local projects that primarily benefit low-income persons. The Town's CDBG allocation for the 2021 Program Year, which covers the July 1, 2021 through June 30, 2022, is \$498,595.

The Town of Hamden has completed a draft substantial amendment of its Fiscal Year 2019 (PY45) CDBG-CV Plan. Hamden received Coronavirus Aid, Relief and Economic Security (CARES) Act funds through CDBG-CV1 & CDBG-CV3 in the total amount of \$642,331 to prevent, prepare for, and respond to COVID-19 for low-and moderate-income persons.
